He also routinely handles regulatory investigations and appeals regarding tax assessments.

Tim's extensive trial, arbitration, administrative, and appellate experience includes:

- Successfully defending the constitutionality of Nebraska's education funding system brought by several school districts.
- Representing a client in litigation involving the storage of spent nuclear fuel, which has resulted in a more than \$105 million in payments to his client.
- Second chairing a trial which secured a \$43.8 million jury verdict for his client for breach of contract, tortious interference, and anti-trust violations. This was believed to be the largest jury verdict in Nebraska history at the time it was entered.
